SINGAPORE - A real estate agent who received \$44,300 in cash from a buyer for the purchase of a new condominium unit later discovered that the man was an undischarged bankrupt and was involved in illegal gambling den activities.

Despite this, Charles Tan Chun Peng from PropNex Realty disregarded his legal obligations and failed to file a report to flag the suspicious transaction.

NATIONAL REAL ESTATE AWARDS (NREA 2021)

Malaysian Institute of Estate Agents (MIEA) (Sarawak Branch) is pleased to announce that KOZIN Real Estate Sdn Bhd has once again been awarded the State Real Estate Firm of the Year (Sarawak) for the 8th consecutive year and also the State Residential Real Estate Firm of the Year (Sarawak) for the 2nd consecutive year at the 13th National Real Estate Awards (NREA).
